Enrollment and Tuition Payment Agreement

This Enrollment and Tuition Payment Agreement (“Agreement”) is made and entered into by and between the Grace Classical Academy, Inc. (hereinafter “GCA”) and the undersigned parent(s), and/or guardian (hereinafter “Undersigned”) and whereas, GCA is a nonprofit educational institution created for the purpose of providing students a program of Christian classical education and a rigorous curriculum in a loving and Christ-centered environment, and whereas the Undersigned are in accord with the policies of GCA and desire to place the student(s) listed below under its teachings and discipline;

Now therefore, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The Undersigned do hereby enroll the student(s) listed below in the grade(s) and for the entire 2018/2019 school year set forth below, and GCA accepts said student subject to the terms of this Agreement. The Undersigned acknowledged that he/she/they have the obligation to pay the applicable tuition and fees set forth herein, together with a book/materials fee to offset the cost of consumable workbooks, resources, licensing fees and the like (not to exceed \$300 per student).
2. Since GCA hires teachers, purchases textbooks, and makes other financial commitments on a yearly basis determined largely in reliance on the Enrollment Agreements, the Undersigned understands that the student(s) listed below is enrolled for the entire school year or such portion as may remain after the date of entrance, and that the Undersigned are obligated to pay all tuition and fees listed in this Agreement for the full academic year unless a written release is agreed to and signed by GCA.
3. The absence, withdrawal, or dismissal of any student during the school year, whether as a result of accident, sickness, disciplinary action, or otherwise, does not relieve the Undersigned of the responsibility for payment of the entire year’s tuition and fees listed in this Agreement.
4. If payment of tuition and fees is not made in accordance with this Agreement, GCA shall have the right in accordance with applicable law to refuse to admit the students to class, to refuse to allow the students to take any examinations and to withhold the transcript or other record of grades awarded for courses completed until all outstanding financial obligations of the Undersigned are satisfied in full.
5. All students are required to meet the academic standards of GCA and to abide by all the rules and regulations established by GCA, including those stated in the GCA Student Handbook, as may be amended from time to time. GCA reserves the right to dismiss any student who does not respect GCA’s standards or provide reasonable cooperation in the education process, or whose conduct is considered detrimental.

6. The Undersigned shall fully cooperate with GCA in matters concerning student-school relationships and shall refrain from any action which is disruptive of discipline or destructive of authority properly exercised by its representatives. A breach of this obligation on the part of the Undersigned shall constitute grounds for the dismissal of any student from GCA.
7. If the Undersigned, or any member of the Undersigned's immediate family, reach a point of disagreement about the student mentioned in this Agreement on any issue of a non-criminal nature with GCA or GCA employees, in keeping with 1 Corinthians 6:1 of the Bible, after withdrawing said student the Undersigned shall submit to arbitration by a three-member board of conciliation rather than taking the dispute to a court. The board of conciliation shall consist of one member of the Undersigned's choosing, one member of GCAs' choosing, and one member of the clergy or leadership of First Baptist Church of Bonita Springs. The Undersigned and GCA agree to be bound by the decision of the three-member board of conciliation.
8. On delinquent installment payments received after its due date, GCA may impose a late payment fee of \$25.00. GCA may also assess a \$100.00 service charge for any payments which are returned due to insufficient funds. If two payments are returned for insufficient funds during any twelve month period, thereafter GCA may require payment in cash, cashier's check, ACH or money order.
9. The Undersigned is responsible for tuition for the entire year. If a student withdraws from GCA, for any reason, the Undersigned has an unconditional contractual obligation to pay the total annual charges for tuition and fees. This Agreement may be terminated by an active military service member in the method and for any of the reasons outlined in Section 83.682, Florida Statutes.
